## **I. INTRODUCTION**

Welcare Medical & Educational Trust was constituted in 2009 with Mr. P M Sebastian as the Managing Trustee. The other members of the trust are Mrs. Celine Sebastian and Mr. Sibin Sebastian. Mr. P M Sebastian holds other positions such as Managing Partner - Welcare Hospital, Vyttila, Ernakulum, Vice Chairman –Lakeshore Hospital & Research Centre Ernakulum, Managing Trustee – Poovakkottu Mani Memorial Charitable Trust Kanjirathanam, Chairman, KMCIMS, Kallissery, Chengannur and Chairman - Bosco Group of companies – Sharjah, UAE.

The Trust aims to establish various medical and paramedical educational institutions in Kerala. Welcare College of Nursing is the first of its kind. The college was established in the year 2010.

### **I.1 Mission**

The College has a central focus to achieve excellence at various levels of Nursing education, clinical practice, research & community services. The College is committed to prepare competent caring professionals who will take up key roles in the continued development of Nursing.

### **I. 3 Administrative Affiliations**

The college is recognized by Indian Nursing Council, Kerala Nurses & Midwife's Council, Govt. of Kerala and Kerala University of Health Sciences, Thrissur. The Govt. of Kerala has issued letter of permission to Welcare College of Nursing for B.Sc Nursing. The College has entered into agreement with Govt. of Kerala regarding fees and seat sharing.

### **III. Eligibility for Admission**

#### **III.1 Selection of Students**

Selection of students is done by the selection committee as per norms prescribed by the Admission Supervisory committee of Government of Kerala from time to time. The selection committee is constituted by Principal, members from the College management council and selected members of College faculty. Admission is on merit basis. Candidates should bring all the documents in original for verification at the time of interview.

#### **III.2 Academic**

- (I) Candidate who have passed the Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent Examination recognized by any of the universities in the state of Kerala with 50% marks in Physics, Chemistry, Biology and English put together are eligible for admission.
- (ii) Relaxation in marks
  - a. Candidates belonging to SEBC (Socially and Educationally Backward Classes) in the state of Kerala with total annual family income up to Rs.6 lakhs will have relaxation of 5% marks. The Scheduled Tribe candidates in the state of Kerala need only a pass in the qualifying examination.
  - b. Those candidates claiming relaxation of marks shall produce necessary certificates under Management Quota. There will be no reservation of seats for SEBC and or SC/ST candidates under Management quota.
- (iii) Eligibility certificates: Candidates who have passed their qualifying examination from places other than state of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS, Thrissur. This should be furnished at the time of interview for admission.

### **III.3 Age**

- (i) Applicants should have completed 17 years of age on the 31<sup>st</sup> May 2024 in the admission year. No relaxation of the minimum age will be allowed.
- (ii) Self-attested copy of relevant page of school record namely SSLC/ICSE/CBSE/certificates showing the date of birth/copy of birth certificate should be furnished along with the application in proof of age.

### **III.4 Categorization of Seat**

**Government seats:-** Merit seats against which the Director, LBS center makes allotment are called Government Seats. Self Financing Colleges and Private self financing Colleges those are willing to share 50% of their seats with the Government.

**Management Seats: - 35%** Seats other than Government seats filled up by management

**NRI seats:-**15 % of the management seats will be allotted for NRI candidates. As per Government order “ An applicant who depends upon his/ her father/ Mother/ Brothers and Sisters ( Inclusive of first cousins)/ Husband/ Wife Brothers and Sisters (inclusive of first cousins of father or mother/ Half Brother/ Half Sister/ Adopted Father or Adopted mother who is working abroad will only be eligible to apply in the NRI category seats.

### **DOCUMENTS FOR NRI**

- i. A candidate, who apply for the NRI seat should submit the Passport copy and Visa/Green card/OCI Documents of their respective sponsors. The job of the sponsor should be mentioned in any of the above documents.

- ii. The visa of the sponsor should be valid till the closing date of admission in respect of the Medical and Allied Courses.
- iii. In case, the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the employment certificate of the sponsor attested by the Embassy/Consulate authorities.
- iv. The certificates clearly establishing the relationship of the sponsor with the candidate shall be obtained from the revenue authorities, as per the G.O (Ms)No.24/14/H&FWDdated06.08.2014.
- v. However, the relationship between the candidate and his/her father/mother, which are recorded in the educational certificates, maintained in the usual course of transaction by the competent authorities, shall be accepted.
- vi. The Candidate shall produce the sworn affidavit from the sponsor in stamp paper worth Rs.200/-.The same shall also be notarized by the Notary public, disclosing that the student is dependent of the sponsor and the all expenses  
i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the sponsor.
- vii. All the certificates/documents required to establish NRI Status/Non Creamy Layer/Minority etc. shall be produced at the time of submission of application itself. The certificate produce later shall not be entertained under any circumstances.

#### **IV. HOW TO APPLY**

Application for admission to B.Sc Nursing course can be registered only online through a single application. The provision for applying online is available at the

Website of [www.welcarecollegeofnursing.org](http://www.welcarecollegeofnursing.org).

In case of submission of more than one application by a candidate, will lead to rejection of the applications for the same course submitted subsequent to the first application.

#### **IV.1 Application Fee**

For all Candidates: -Rs1000/-only, Payable through online.

The application fee once remitted will not be refunded under any circumstances.

### **Important**

- (a) Documents/Certificates furnished after submission of the application will not be entertained under any circumstances.
- (b) No opportunity will be given to incorporate any details or documents after the submission of application except for those whose results are not declared before the last date of the submission of application.

## **V. Preparation of Merit list**

Merit list:

- 50% of government merit seats will be filled based on LBS rank list.
- 35% seats will be filled by management from among the applications received and on the basis of marks obtained in the optional subjects (Physics + Chemistry + Biology and English) for the qualifying examination.
- Remaining 15% NRI seats shall be filled from qualified students as per G.O. The original documents shall be submitted at the time of admission.
- Resolution of ties while ranking: in the case of tie in the total marks, the marks in Biology will count. If there is still a tie the marks in Chemistry and Physics will count. If a tie still exists, the total score of the qualifying exam will be considered.
- Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicants satisfy the rules regarding the eligibility for admission and other conditions as laid down in the prospectus.
- Furnishing of false information/particulars would result in the cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law.



- Call letter for interview will be sent to each candidate from the college and oral interview will be conducted.

## **VI. Admission & Payment of fees**

The selected candidates will be informed about the date and time of admission.

The students shall pay all fees of the 1<sup>st</sup> year of the course at the time of admission which will not be refunded. Fee stipulated by the fee regulatory committee/Govt. of Kerala is as follows: (Last year as per Admission Supervisory Committee)

Tuition fee Rs.73,025/-

Special fee Rs. 23, 300/- First year and Rs.19, 300 from second year onwards. Caution deposit Rs.10,000/ (Refundable)

Other fees due to statutory bodies (KUHS, KNMC &INC) as and when notified. Hostel fee Rs. 3000/- (per month) and should be paid in advance in the beginning of the year.

Tuition fee for the NRI sponsored candidates will be of Rs. 95,000/- per year as per G.O. Special fee Rs.23,300/-First year and Rs.19,300 from second year onwards

Levy of fee on provisional basis is subject to modification depending on the fee Regulated by the FRC. This fact shall be specifically stated in the prospectus.

The College is not entitled to retain the first year tuition and other fees, if the student discontinues the course before the last date of closing of admission stipulated by the competent authorities.

## **VII. Special Instructions**

- a. **Ragging:** Ragging in any form is strictly prohibited in the college. Hence any student who indulges any form of ragging will be subjected to penal action as

per provisions of law. Also the student will be expelled from the colleges detailed in the law concerned and as per the Honorable Supreme Court of India directions in this regard.

- b. Any other items not specially covered in this prospectus will be decided by the under signed, and the management decision shall be final.

### **VIII. Undertaking regarding non involvement in ragging**
